Experience

- Assisted a hospice provider through redetermination and reconsideration appeals of a Unified Program Integrity Contractor (UPIC) audit to reduce their initial overpayment determination of more than \$400,000 by 60+ percent.
- Through advocacy during the Supplemental Medical Review Contractor (SMRC) discussion
 and education session and re-review process, helped client reduce initial high error rate to less
 than 14 percent.
- Assisted in guiding multiple hospice providers through survey responses, both from state agencies and accreditation organizations.
