Husch Blackwell Sanders Boasts Six Missouri Attorneys Named "Up and Coming Lawyers"

Husch Blackwell Sanders attorneys Hayley E. Hanson, Patrick D. Kuehl, Crystal G. Lovett-Tibbs, Steven F. McCandless, Fang Shen and Richard E. Walters were named as six of *Missouri Lawyers Weekly's* "Up and Coming Lawyers." In total four dozen attorneys were profiled as "Up and Coming Lawyers" in the July 28 issue.

According to *Missouri Lawyers Weekly*, the attorneys profiled represent determination – in legal work, community betterment and improving their own law firms. Missouri Lawyers Weekly editors examined nominations without regard to practice area, race, gender or geographic area.

Partner Hayley Hanson, Kansas City, Mo., focuses her practice in education law, representing school districts, colleges and universities. She has successfully argued cases before the 8th Circuit and the Missouri Court of Appeals, Eastern District. Hanson played a pivotal role representing the Kansas City, Missouri School District in the final unitary status hearing in the decades-long school desegregation case. Recently Hanson was named "Young Alumni of Year" by Northwest Missouri State University.

Partner Patrick Kuehl, Kansas City, Mo., is a licensed patent attorney practicing in the firm's Commercial Litigation Division. His background in chemical engineering led him to focus on intellectual property law. Kuehl has experience prosecuting and defending patent, trademark, and copyright infringement cases in federal courts throughout the country as well as registration and opposition proceedings before the United States Patent & Trademark Office. According to the article Kuehl, "... loves trials, but the challenge is finding a solution other than litigation that helps the client's

Associate Crystal Lovett-Tibbs, St. Louis, Mo., focuses her practice in environmental law. It was an Earth Day celebration in the mid-80s that sparked her interest in the environment. Now Lovett-Tibbs assists large corporations that are ordered to pay for environmental cleanup by seeking the smaller companies that also contributed to the matter, making sure everyone "pays their fair share." In addition to her work at the firm, Lovett-Tibbs has been an active volunteer with Barack Obama's campaign, and in August she will attend the Democratic National Convention in Denver as an elected delegate at large.

Partner Steven McCandless, St. Louis, Mo., focuses his practice in commercial finance. McCandless' work includes projects involving both historic and new markets tax credits.
