He has served as an adjunct professor at the University of Nebraska College of Law, teaching courses in appellate advocacy, trial advocacy, legal research and legal writing.

Weeks has recently focused his practice on civil litigation, primarily in the areas of agricultural, commercial, constitutional and trademark law. He also has extensive criminal litigation experience, having handled hundreds of cases in his former capacity as a public defender in both Pierce and Lancaster counties in Nebraska. While serving in general practice in Norfolk, Neb., he participated in a capital murder case and filed a motion to test the DNA of a client, who was ultimately cleared of a first-degree murder conviction, after serving 19 years of a life sentence in prison. Previously, he was a law clerk for the Nebraska Attorney General in 2001 and 2002.

Weeks received his B.S. in 1999 from the University of Nebraska-Lincoln, with a major in criminal justice and an emphasis in Spanish. He received his J.D. from the University of Nebraska College of Law in 2003.
