# American Inns of Court Honors Two Husch Blackwell Partners with Linn Inn Alliance Distinguished Service Medals

## **Julie Katz and Edward Manzo Among Six Receiving National Recognition**

On March 23, Husch Blackwell's Julie A. Katz and Edward D. Manzo received Linn Inn Alliance Distinguished Service Medals at the annual New York Intellectual Property Law Association's Judges Dinner.
