The *Chambers USA* directory highlighted the firm's work and dedication to client service across multiple practice areas, including:

**Banking & Finance.** The team "handles a variety of commercial and public finance matters, ranging from complex financing transactions to tax credit issues, due diligence and intercreditor agreements," with one client noting, "I believe they perform at the highest level. **Corporate/Commercial.** Husch Blackwell "offers notable proficiency in M&A, corporate governance and securities matters" and "has commendable experience working with clients from the renewable fuel, energy and agribusiness sectors."
