She was also instrumental in helping Massachusetts expand access to NARCAN® naloxone a drug that can reverse opioid overdoses. Prior to DPH, Rodman was a hearings officer for the Massachusetts Division of Professional Licensure and assistant general counsel of the Massachusetts Board of Registration in Medicine. She also served as a law clerk at the Appeals Court of Massachusetts to the Hon. Benjamin Kaplan.
