## Catherine L. Hanaway, Husch Blackwell Partner and Former Chair, Named Missouri Attorney General

National law firm Husch Blackwell is pleased to announce partner and former firm chair, Catherine L. Hanaway, will serve as the next Attorney General for the State of Missouri. At a press conference today, Missouri Governor Mike Kehoe announced her appointment which will fill the vacancy created by President Trump's appointment of Attorney General Andrew Bailey as Deputy Director of the Federal Bureau of Investigation.

Hanaway will be the state's 45th Attorney General and will assume the role on September 8, 2025.

Hanaway joined Husch Blackwell in 2013 and helped build the firm's national white collar practice. She held several leadership positions at the firm, including serving as a practice specialty group leader and as Chair of the firm

from 2021 to 2024. In addition, she spent many years in public service to the State of Missouri. She served as U.S. Attorney for the Eastern District of Missouri, Speaker of the Missouri House of Representatives, and spent five years on staff for U.S. Senator Kit Bond.
