**With two decades of experience at the Commodity Futures Trading Commission (CFTC), Jeff represents companies trading billions in global financial markets.**

He represents clients in civil and criminal government investigations and enforcement actions, internal investigations, litigation, and regulatory compliance matters. Before entering government service, Jeff served as a first-chair partner in commercial and financial litigation matters at a major law firm. In 2005, he joined the CFTC's newly established enforcement in Kansas City, where he spent 20 years leading high-profile investigations and litigations involving financial fraud and manipulation. Jeff led teams of attorneys, investigators, and forensic economists—often in parallel with state and federal authorities—to develop and prosecute complex financial fraud and manipulation enforcement actions. He played a key role in the CFTC's adaptation to electronic trading and pioneered the use of data analytics to uncover and litigate trading misconduct.

Notably, Jeff's leadership in the landmark CFTC v. Sarao investigation and litigation led to a detail with the Department of Justice's Fraud Section (Criminal Division), where he further advanced data-driven investigative and litigation strategies in both civil and criminal settings.
