OVERVIEW

Bryan focuses his practice on toxic tort, product liability and business litigation.

Bryan defends chemical and petrochemical manufacturers and is extensively involved in single plaintiff, mass tort, multidistrict and class action litigation alleging personal injury from exposure to asbestos, benzene and various solvents. He plays a leading role in managing large joint defense groups comprising a variety of national corporations. Bryan also handles product liability matters for clients in the construction materials industry.

Bryan represents several Fortune 500 corporations and has defended clients in some of the most plaintiff-friendly venues in the country, including the City of St. Louis and Jackson County, Mo., Madison County and Cook County, Ill., as well as in California, Washington, Maryland and Iowa. product liability claims were dismissed and remainder of the case was dismissed on summary judgment on the basis of the statutory employee defense.

He was also on the Marine trial team that prosecuted two Marine aviators involved in an Italian cable car strike. In November 2001, Bryan was mobilized by the Marine Corps for service in support of Operation Enduring Freedom. During his eight-month mobilization, he worked on numerous legal issues, including the status of detainees captured in Afghanistan, procedures for military tribunals and the Walker Lindh investigation.

 manufacturing process and the product has not yet left the manufacturing facility. The
 remainder of the case was dismissed on summary judgment, on the basis of the statutory
 employee defense.
- Defended client against benzene exposure allegations in the State of Washington.
- Managed large joint defense groups in benzene exposure cases in numerous jurisdictions
 resulting in favorable resolution for clients. These cases were defended in some of the toughest
 and most plaintiff-friendly venues in the country, including "judicial hellholes" (as identified by
 the American Tort Reform Association) in Missouri and Illinois.
