 on Tennessee Valley Authority project. Claim was for approximately \$3.7 million. Trial court
 dismissed case for failure to state claim at close of plaintiff's case. Ruling was reversed and
 remanded by Missouri Supreme Court. Case settled prior to retrial for approximately
 \$150,000. Murphy v. A.A. Matthews, St. Louis City Circuit Court (Mo. 1997)
- Established economic loss doctrine in Missouri. Fleischer-Seger Construction v. Hellmuth, Obata & Kassabaum, 870 S.W.2d 832 (Mo.App.E.D. 1993)
