Linda also prepares transmission rate filings under the Federal Power Act (FPA) to establish forward-looking formula-based rate and incentive-rate treatments favorable to clients. She guides clients through North American Electric Reliability Corporation (NERC) matters, as well as interconnection and regulatory issues underlying corporate and financial transactions in the energy sector.
