#### **Court Sets Aside \$5 Million Default Judgment Case**

When a national restaurant chain did not respond quickly enough to a lawsuit, the court entered a default judgment of \$5 million. The restaurant chain needed a determined team of attorneys to persuade the court to set aside the judgment. With no time to lose, Brittany wrote the motion to set aside the default judgment and the brief requesting that the court grant the motion based on excusable neglect. The team argued the issue and convinced the court to set aside the \$5 million judgment.
