## **\$2.9 Million Secured in High Stakes Contract Dispute**

Kayla's courtroom presence was instrumental in winning a \$2,934,961.13 judgment in favor of LMI Aerospace concerning the breach of a supplier agreement. Kayla's leadership also allowed the client to completely defeat a \$15,000,000 counterclaim asserted by the defendant. The judgment included over \$1,000,000 in attorneys' fees and prejudgment interest awarded by the court, finding that Kayla's work was "excellent" in a complex case. *LMI Aerospace, Inc. v. Intelsat Inflight, LLC*, Case No. 209L009002 (Cook County Circuit Court).
