 Contractors (UPICs), Medicare Administrative Contractors (MACs) and Medicaid Integrity
 Contractors (MICs), reducing overpayment claims through analysis and rebuttal of technical,
 clinical and statistical positions of auditors.

HEALTHCARE & GENERAL LITIGATION

- Successfully represented hospice provider in False Claims Act (FCA) and Anti-Kickback Statute (AKS) case before U.S. District Court for the Southern District of Georgia and the U.S. Court of Appeals for the Eleventh Circuit, securing non-intervention decisions by state and federal authorities, dismissal of all claims at the District Court, and affirmance of full dismissal at the Court of Appeals.

- In pro bono case, successfully overturned summary judgement on deliberate indifference claim in U.S. Court of Appeals, Seventh Circuit, on behalf of inmate client working as an electrician who received severe electrical shock due to equipment precautions not taken.

Experience

- Represented hospice in appeal of a Medicare audit that resulted in an extrapolated overpayment of more than \$12 million. Advocated for the hospice through the appeal process including a hearing before an administrative law judge. The extrapolation was thrown out and the ALJ returned a fully favorable ruling, resulting in a final overpayment amount of \$0.00.
- Successfully represented a client against a Medicare reimbursement audit by the OIG, which initially alleged improper payments of over \$140 million (later reduced to a \$50 million demand). Through a comprehensive appeal process including expert testimony on statistical sampling and hospice care determinations, the Husch Blackwell team achieved a remarkable victory when an administrative law judge overturned nearly all claim denials, reducing the extrapolated overpayment to less than \$10.
