PRODUCT LIABILITY

- Defended a generic pharmaceutical manufacturer in a third-party claim arising from a violent assault, where the assailant sought to shift liability onto his mental health providers and medication manufacturers in State of Wisconsin, Dodge County Circuit Court. Moved to dismiss on grounds that federal preemption barred any failure-to-warn claim against a generic drug manufacturer and that state law independently precluded indemnification or contribution for a tortfeasor's own intentional conduct. Facing the motion, the third-party plaintiff voluntarily dismissed all claims with prejudice, fully resolving the client's exposure early in the litigation.
- Defended a medical device company in an action where a nurse was allegedly injured by a malfunction of a robotic surgical system. Natalie filed a key motion in limine to exclude the plaintiff's experts that were to opine as to the purported malfunction, while simultaneously filing a summary judgment motion. As a result of the motion in limine that was granted, the likely outcome of the summary judgment motion would also be granted. Thus, the parties favorably resolved on the eve of the hearing.
- Defended talc supplier in personal injury matter in seven-week jury trial in the Superior Court of California, County of Los Angeles. Obtained mistrial judgment.
- Represents global automotive parts manufacturer and specifically manages over 50-70 California litigation matters to achieve the client's business objectives in the most efficient and economic manner possible.
- Defended pesticide/herbicide manufacturer in high profile personal injury matter involving a minor child in the Superior Court of California, County of Solano. Less than one week before voir dire was to commence, obtained a dismissal following recent rulings on motions in limine and Sargon motions regarding plaintiffs' experts.

- Represented homeowner in contractual dispute based on fraudulent business practices of a general contractor in a five-day trial in the U.S. Bankruptcy Court, Northern District of California. Obtained plaintiff's verdict for full award of damages sought.
