#### **OVERVIEW**

With a background at the Public Utility Commission of Texas (PUCT), Dakota advises clients on complex energy regulatory matters.

Dakota's primary focus is general energy regulatory work for power generation companies, retail electric providers, and qualified scheduling entities. He represents clients before the PUCT and Electric Reliability Council of Texas (ERCOT) and provides guidance on a number of regulatory matters he worked with frequently as a PUCT attorney.
