OVERVIEW

Aleksandra's commercial practice includes breach of contract, breach of lease agreement or related landlord/tenant disputes, real estate matters, and other business disputes. She regularly represents a national bank in various lending lawsuits, including breach of loan security litigation. As a natural writer, Aleksandra routinely drafts motions for the court and assists with discovery, and she frequently takes depositions.

Aleksandra knew she wanted to be an attorney from a young age: with strong advocacy skills, she simply couldn't imagine herself pursuing any other career, and she knew she was meant to be a litigator. As a law student, she served as a Husch Blackwell summer associate, cutting her teeth on asbestos litigation, constitutional work for a pro bono client, and general commercial litigation. She also externed with the U.S. Attorney's Office for the Northern District and the Cook County Circuit Court, where she learned to dig deep into legal questions and gained excellent research skills.
