Only up to five percent of attorneys in a state are named *Super Lawyers*. Selecting the attorneys involves an in-depth, measurable process. Peer nominations by seasoned attorneys followed by detailed evaluations are matched against third-party research. Each candidate is evaluated on 12 indicators of peer recognition and professional achievement. Selections are made on a state-by-state basis annually.

No more than two-and-a-half percent of attorneys in a state are named *Rising Stars*. The lawyers who make this list must be under 40 years old and have less than 10 years of legal experience. They go through the same selection process as *Super Lawyers*, excluding the peer evaluations.
