# Chambers USA 2018 Ranks Husch Blackwell in 10 Areas of Law; 37 Attorneys Recognized

Chambers USA 2018 has ranked Husch Blackwell in 10 practice categories and recognized 37 lawyers in 11 offices across the firm. The firm earned rankings in the areas of Banking & Finance, Corporate/Commercial, Corporate/M&A, Environment, Healthcare, Intellectual Property, Labor & Employment, Litigation: General Commercial, Natural Resources & Environment and Real Estate.

**Banking & Finance.** With "specialties that include industrial revenue bonds and the representation of agent banks in syndicated loan negotiations," Chambers said the Husch Blackwell team is known for its ability to "handle a variety of commercial and public finance matters."
